# 2. Human Resources

a) College Intern

b) Local AIS Ordinances Chapter 30

GLEA hosted the training with the DNR. The Villages of Fontana, Williams Bay and Lake Geneva all had officers in attendance. The ordinance that was adopted only adopted the definitions of Aquatic Invasive Species, which will require that the officers identify the AIS and issue a ticket for the specific species. Both Fontana and WB police chiefs felt that this would be difficult to enforce. They will bring this back to their municipalities to state any aquatic plant matter is not allowed to be transported. Lake Geneva officer was going to do the same and talk with the police chief and attorney as well to see about getting the ordinance amended.

# 4. Grants/Projects/Equipment

a) Macroinvertebrate Survey, Aquatic Plant PI, Nearshore Fisheries Survey

The Macro Survey will be in September. The PI survey will be sometime around the end of June and July. The Nearshore will be at the end of June and the beginning of July.

#### c) Fontana Drone Club

Fontana Drone Club will be doing wake enhancement drone survey, buoys, and pier surveys. They will work directly with DNR on that portion, as Fontana will incorporate it as part of a summer school project and apply for a community foundation grant for boats.

#### d) Clean Boats Clean Waters

The County has hired an LMPN Intern. Once training is scheduled GLEA will contact the municipalities with the date and times. They are looking at the week before Memorial Day. Director Schmidt is working on becoming a certified CBCW trainer as well.

# e) GLEA APP

A prototype app for the GLEA was discussed. It would help streamline fieldwork. Look at budgeting for next year.

#### a) Newsletter

# b) Wisconsin Lake's Convention

Director J. Schmidt attended the WI Lake's Convention, and there were numerous sessions on wake enhancement. Several lakes in SE WI have successfully passed local ordinances restricting the use of ballast, wake shaping devices, and wake enhancement features.

# c) Walworth County Lakes Association

The GLEA will be hosting the Walworth County Lakes Association meeting in October, featuring Wisconsin DNR AIS staff. They will talk about the local AIS to Walworth as well as what is happening at the federal level.

## d) Informational Meeting with DNR

The GLEA will try to schedule an informational meeting for late May or Early June with the DNR for a Saturday morning or during the week after 5 pm.

# e) Lake Management Plan Focus Groups
